That, in under to effectuate his aforesaid desire, these, the founder has set apart handed over to the trustees out of his inherited property, a sum of Rs. 1,01,00 (Rupees One Lac One Thousand only) (hereinafter called the 'Trust Fund' vexpression shall include cash and any other property or investments of the whatsoever into which the same or any thereof might be converted, invested varied from time to time or which may be acquired by the trustees or may contain their hands by virtue of these presents or by operation of law or other howsoever in relation to these presents), and the trustees shall hold and possessed of the same upon the trust subject to the powers, provisions, agree and declarations hereinafter contained.
- 2. That the name of the trust shall be 'SIDHNATH EDUCATIONAL TRUST its office shall, for the presents, be situate at Sidhnath Nagar, Japla, Pal (Jharkhand) and/or at such other places as the trustees may decide from time.
- 3. That the objects which this is established are:
 - (a) To establish a non profit educational organization devoted to the some upliftment of poor and down trodden class and other class of and to give them professional, technical and job oriented education charitable way.

- 9. That for the furtherance of the objects of the trust, the founder trustees shall the following powers:
 - (a) To accept any donation, contribution, grant or subscription in cash or from any person(s), body of persons or trust/society, Corporate S Government with or without conditions.
 - (b) To apply the whole or any part of the income of the trust, or the trust for accumulations thereto, to any one or more of the objects of the trust, to trustees may, in their discretion, deem fit from time to time.
 - (c) To convert and deal with the trust property and/or any investment for time being.
 - (d) To open account in the name of the trust, trustee and/or Institutu/conducted by the trust with a Bank or Banks, to operate such account to give instructions to the bank and to provide for opening and open of such account by one or more of the trustee or by an agent appoint the Trustee.
 - (e) To set apart and/or allocate the whole or a part of the income or the confidence of the Trust Fund or part thereof for any of the objects of the Trust.
 - (f) To accept any Loan or Advance from any person(s), body of perstrust, bank, financial institution with or without conditions.

- 11. The Trustees will not be entitled to receive any remuneration but the Trustees reimburse themselves all expenses actually incurred by them in connection wi Trust or their duties relating thereto.
- 12. The number of trustees shall not be less than two and more than Nine. If the name of trustees shall fall below two, the trustee shall not, except for the purpo: filling any vacancy, act so long number is below the said minimum.
- 13. Every trustee will be at liberty to resign on giving one month's notice intention to do so.
- 14. The management committee may form time to time frame rules for the conduregulations of the meetings of trustees. In the absence of such regulations two of the total trustees shall form a quorum for a meeting.
- 15. The accounting year of the Trust shall be the financial year ending on 31st. every year.
- 16. The Trust and the Trust Funds shall be irrevocable for all times.
- 17. The founder trustee shall hold have superintendence over the affairs of the and shall have in particular the power to operate the bank account of trust with one of the other trustee as may be decided by the board of trustees.


